# **TRANSITION REQUIREMENTS TO SANS 10330:2020**

# SAATCA CERTIFICATED AUDITORS

#### This document describes the transition requirements to ensure that SAATCA certified Auditors are competent on the SANS 10330:2020 standard version.

#### Compulsory transition requirements for SAATCA Certificated HACCP Auditors

SAATCA Auditors certificated to HACCP will be required to:

- Successfully complete Auditor transition training on the FDIS or published SANS 10330:2020 standard to be certificated as competent to conduct audits against the SANS 10330 standard version.
- Successfully complete Auditor transition training on the FDIS or published SANS 10330:2020 standard, on or before **28 February 2022.**
- Conduct a minimum of two (2) audits against the <u>published</u> SANS 10330:2020 standard to be certificated as competent to conduct audits against the 2020 standard version.
- For certification purposes, SAATCA will only accept audits performed after successful completion of the Auditor transition training. Such audits must be done against the <u>published</u> SANS 10330:2020 standard.

# SANS 10330:2020 Auditor Transition Training Requirements

SAATCA Auditors certificated to any of the HACCP grades will be required to attend SANS 10330:2020 Auditor transition training which complies with the following SAATCA requirements:

- The SANS 10330:2020 Auditor transition training must comprise of a two-day transition training course.
- The SANS 10330:2020 Auditor transition training must be presented and facilitated by a SAATCA registered FSMS Training Course Provider. The facilitator his/her SAATCA HACCP registration number must be captured on the certificate of successful completion for the SANS 10330:2020 Auditor transition training.

A certificate of successful completion of a two-day SANS 10330:2020 Auditor transition training will be accepted only if the certificate meets the following requirements:

- The certification states that the training is for the SANS 10330:2020 Auditor transition training and is based on either the FDIS or the published standard.
- The training is for a duration of 2 days.

#### SOUTHERN AFRICAN AUDITOR AND TRAINING CERTIFICATION AUTHORITY (NPC)

The training course provider name and the Facilitator who presented the training and his/her SAATCA HACCP registration number are reflected on the certificate of successful completion.

# Validity of Certifications to SANS 10330:2020

Your current SANS 10330:2007 certifications will not be valid after three years from publication of SANS 10330:2020. The expiry date of Auditor certifications to SANS 10330:2007 issued during the transition period will automatically become invalid at the end of the two-year transition period for SANS 10330:2020.

#### SAATCA Registered Auditor Transition Timeframes for SANS 10330:2020

Two years after publication of SANS 10330:2020, all existing certifications issued to SANS 10330:2007 shall be deemed invalid.

# ANNUAL RE-REGISTRATIONS

ANNUAL RE-REGISTRATION WILL TAKE PLACE EVERY 12 MONTHS AS PART OF AN AUDITOR'S SURVEILLANCE ACTIVITY FOR THE MAINTENANCE OF HIS/HER CERTIFICATION.

IT IS RECOMMENDED THAT WITHIN ONE YEAR AFTER PUBLICATION OF SANS 10330:2020, ALL SAATCA CERTIFICATED HACCP AUDITORS SHOULD HAVE COMPLETED THE SANS 10330:2020 2 DAY AUDITOR TRANSITION TRAINING IN ACCORDANCE WITH SAATCA TRANSITION REQUIREMENTS

# **3 YEARLY RE-CERTIFICATION CYCLE**

RE-CERTIFICATION ON A THREE (3) YEAR CYCLE IS REQUIRED OF EACH AUDITOR IN EACH REGISTERED GRADE PER SCHEME.

SAATCA AUDITORS ARE RESPONSIBLE TO ENSURE THAT THEY SUBMIT THEIR SANS 10330:2020 TWO DAY AUDITOR TRANSITION TRAINING AND APPLICABLE AUDIT LOGS TO SAATCA WITHIN THEIR 3 YEARLY CERTIFICATION CYCLE OR AT THE LATEST, BY 28 February 2022.

**Note:** All SAATCA auditor certifications to HACCP expires on 28 February 2022 and are no longer valid after this date. Any transition submissions received <u>after</u> 01 March 2022 will be treated as a <u>new application</u> and will be subject to the applicable fees.

**Note:** The dates contained in this document are based on the current understanding that the SANS 10330:2020 has been published on **05 February 2020**.
